I. Overview

The Boston Public Health Commission (BPHC) is the local public health department for the City of Boston. BPHC's mission is to protect, preserve, and promote the health and well-being of all Boston residents, particularly the most vulnerable.

As part of BPHC's efforts to have an equitable procurement process, BPHC will consider and encourage unrepresentative businesses that includes Minority-owned Business Enterprises (MBE), Women-owned Business Enterprises (WBE), Veteran-owned Business Enterprises (VBE), Disability-owned Business Enterprise (DOBE), Lesbian Gay Bisexual Transgender Business Enterprises (LGBTBE), and local businesses to apply to this RFB.

The Boston Public Health Commission, acting through its Information Technology Services Department invites competent persons, firms or corporations to apply for a request for bids for the Public Safety Department video control room design, configuration, and integration of current video surveillance cameras and to perform such work in coordination with BPHC Officials as it relates to the enclosed Scope of Work.

II. Introduction

The Boston Public Health Commission (BPHC) is seeking bids from qualified public safety surveillance system firms to provide a new design, configuration, and integration of video control room for the Public Safety Department, with the ability to expand to additional surveillance cameras in the control room. The video control room shall include software, video control hardware, power, electrical receptacle, CAT 6A cable, ethernet jacks, HDMI cable, HDMI jacks, TV monitors, rack mounted PC/appliance, full rack, and furniture installation. The City owned video surveillance camera management software - Genetec must be used for viewing video surveillance cameras at the public safety video control room.

BACKGROUND

The BPHC operates and maintain (296) Axis CCTV IP Cameras. The storage area network (SAN) and Genetec software are maintained by the Department of Innovation and Technology at the City of Boston.

The BPHC Public Safety Department operates 24 hours a day, 7 days a week.

The City of Boston Records Retention Policy for Video footage is currently 30 days and unlimited storage if flagged.

The BPHC Public Safety Department video control room is approximately 700 - 800 square feet room.

OBJECTIVES

The objective of this Request for Bid (RFB) is to provide design, configuration, and integration of public safety video control room to monitor live video surveillance feed of the BPHC facilities, both interior and exterior.

The BPHC's expectations with the public safety video control room include, but are not limited to:

- a) Improved video control room facility
- b) Improved Management and Operations
 - I. Ability to Manage Video Control System on the Monitors
 - II. User Friendly Video Control Hardware System
 - III. Ability to Flag or Copy Surveillance Video for Evidentiary Purposes

III. Scope of Work

- A. The general contractor and or their sub-contractor shall provide a new design configuration, and integration of the public safety video control room
- B. The general contractor and or their sub-contractor shall provide software, video control hardware, power, electrical receptacle, CAT 6A cable, ethernet jacks, HDMI cable, HDMI jacks, TV monitors, rack mounted PC/appliance, rack installation and any other related furniture for the video control room to monitor live video surveillance
- C. The general contractor and or their sub-contractor shall provide all engineering, design, integration, labor, commissioning, materials, transportation, and equipment to provide a complete functional system in accordance with the video surveillance software Genetec and emergency call boxes (VOIP)
- D. The general contractor and or their sub-contractor shall be responsible for all coordination with other trades (including electrical) as applicable to ensure a functional complete system. General Contractor is responsible for resolution of conflicts with connection of and/or interaction of other systems including conduit, back boxes, floor boxes and pull boxes
- E. The general contractor shall be responsible to ensure that all means of support, suspension, attachment, fastening, bracing and seismic restraints used on the project are in accordance with all local, state, and federal building codes

- F. The system will not be considered a complete functional system until all equipment's are tested and functioning without defect
- G. The general contractor and or their sub-contractor shall label all the wiring and equipment at the public safety video control room
- H. The general contractor and or their sub-contractor shall provide wiring diagram of all the equipment installed at the public safety video control room
- I. The general contractor and or their sub-contractor shall remove all trash generated by the installation from the site. This includes all wiring and materials not being reused. It is expected that where appropriate, recycling of materials will be done. All recycling is to be done in compliance with local, state, and federal laws.
